A Top Priority

"The National Association of Clean Air Agencies (NACAA) condemns racism and discrimination in all its manifestations. While the work of our state and local agency members has contributed to tremendous reductions in air pollution overall in the United States, the same communities that bore the greatest burden of harm decades ago continue to face the greatest public health threats from dirty air today. Some systems produce unequal and inequitable outcomes even when the people who implement them have the best intentions. As a community, NACAA will work for systemic racial justice in the programs that alleviate polluted air, in our externally facing programs, and in our internal operations. Because silence and inaction are themselves policies, in the coming 12 months NACAA will advance this goal by opening a dialogue to explore and take action on fundamental questions, including but not limited to, 1) How does our association currently express diversity, access, equity, and inclusion? 2) How do we advance and support equitable and just policies and programs that address diversity and prevent discriminatory outcomes? 3) Do NACAA and our member agencies reflect the diversity of the communities we serve? and 4) What can NACAA, as its own community, do to make a difference?"

- 2) Respect State and Local Authorities as a Pillar of the Clean Air Act
- 3) Ensure Scientific and Technical Integrity for Core EPA Actions
- 4) Advance New EPA Programs to Protect Public Health and the Environment and Address Climate Change
- 5) Reset Permitting and Enforcement Priorities to Emphasize Public Health and Equity
- 6) Improve Technical Assistance to State and Local Air Agencies
- Address the Urgent Need for Significant Increases in Federal Funding
- 8) Act in Partnership with State and Local Clean Air Agencies.

- Protecting Public Health and the Environment and Restoring
 Science to Tackle the Climate Crisis
 - √ Re-join Paris Agreement
 - ✓ Review 48 Deregulatory Actions: <u>The List at EPA</u> from "Build Back Better"
- √ National security reviews for climate impacts
- √ Pause new O&G leases; revoke KXL permit
- ✓ Eliminate fossil fuel subsidies by Federal Govt
- ✓ Establish Climate Conservation Corps
- Social cost of carbon
- √ HFCs leak detection, Kigali
- Orders on restoring & elevating science, establishing environmental justice institutional infrastructure

De-Regulatory Pauses

- Benefit-Cost Analysis (Among others at EPA)
- Promoting Energy Independence & Economic Growth
- Establishing Discipline and Accountability in the Environmental Review and Permitting Process for Infrastructure Projects
- Expediting Environmental Reviews and Approvals for High Priority Infrastructure Projects
- Efficient Federal Operations (Restores "Planning for Federal Sustainability in the Next Decade")
- The 2-for-1 Rule



Changes on the Hill

- New Senate Leadership (EPW, Approps, etc).
- New bills
 - √ CLEAN Future Act
 - √ Republican EPA Energy Package
 - √ Numerous smaller bills
- Much broader range for action (likely through reconciliation)
- COVID stimulus
- 2 large infrastructure packages in the pipe
- Appropriations / "Skinny Budget"



The Courts are Making Decisions

- ACE Rule vacated in court 1/19/21
- DC Circuit granted EPA's and NHTSA's 2/1/21 motion to hold SAFE Part 1 in abeyance
- Transparency In Regulatory Science vacated 2/1/21
- These rules are under review by Biden EPA and also subject to litigation:
 - √ Safe Part 2
 - ✓ Aircraft GHGs (fin. 1/11/21)
 - ✓ New Power Plant NSPS under 111b (fin 1/13/21)
 - ✓ Methane NSPS for O&G
 - √ Trailer sections of Phase II Heavy Duty rule (stayed 9/20)



Companies are responding

- GM, Toyota, Hyundai, others withdraw from SAFE litigation
- Investments in EVs: GM "aspires to eliminate tailpipe emissions from new light-duty vehicles by 2035"; multibillion battery investments for GM, Ford, VW
- EEI Op-Ed: 100% zero emissions "possible with the right alignments"
- EPSA announcements: support for broad electrification, decarbonization through market design
- API would "accept" "the right type of" "carbon tax"

Federal Policy: Priorities and Draft "Asks"

1. Forest Health Investments

- Match California's proposed \$1 Billion for wildfire mitigation
- U.S. Forest Service commitment to treat 500,000 acres of CA forests annually
- Clean Air Centers
- Incentives for biomass utilization

2. Grid Reliability and Electrification

- Electric Vehicle (EV) charging infrastructure
- Energy storage
- Hydrogen
- Climate change (2021 Texas blackouts)

3. Transportation Infrastructure

 HR 2: Passenger rail, transit, goods movement, bridges, airports, ports, highways, and more

4. SAFE Vehicles Rule Part 1/2

 Restore stronger emissions standards for passenger vehicles

5. Heavy-Duty Truck Emissions

- Tighten standards for Nitrogen Oxides (NOx) emissions
- Must be a 50-state-strategy due to interstate trucking and commerce

6. Funding for Local Projects

- Case-by-case basis
- Earmarks are popular again



REAUTHORIZATION OF STATE INCENTIVE PROGRAMS FOR CLEAN AIR PROJECTS

- SUNSETTING IN -2023 UNLESS REAUTHORIZED
- CARL MOYER/AB 923 INCENTIVES and AB 8 CLEAN AIR PROGRAMS
- MULTIPLE BENEFITS TO PARTICIPANTING BUSINESSES AND REGIONAL ECONOMIES
 - Private businesses, farmers, schools, public agencies, communities
- CRITICAL FOR AIR QUALITY PROGRESS
 - Since 1998, 68,000 combustion engines cleaned up to tune of 194,000 tons of NOx + ROG and 7,100 tons of PM avoided emissions statewide
 - School bus replacements, agricultural equipment, passenger car scrapping, etc.
- AB 617 COMMUNITY AIR PROTECTION PROGRAM (CAP)
 - Unkept promise for communities, air districts, and other stakeholders
 - Communities asking for tangible benefits yesterday
 - 3-year old state mandate that has been continually underfunded
 - No continuous appropriation, yet more state requirements being added (e.g., CTR, AB 1001, etc.)

Notes: CTR=Criteria Pollutant and Toxics Emissions Reporting regulation, AB 1001=Environmental Permitting and Air Pollution.

NEW LEGISLATIVE FLEXIBILITY TO STATE INCENTIVES

- Historical issues with disinvestment, redlining, and poor land use planning will take time and a concerted collective effort to correct
- Solutions are beyond air quality actions. However, we can do more with additional and targeted flexibility for eligible projects
- Create a pilot in Sac Metro Air District (potentially others) to add flexibility for Moyer/CAP to fund broader type of incentive projects
- Examples: tree/solar canopy, streetscapes, bike lanes, cool pavement, cool roofs, EV purchase w/o scrap










WILDFIRE MITIGATION AND RESPONSE



- More state investment to expand opportunities for prescribed burning for land management (SB 1260)
- \$2M/year implemented by air districts, ARB, CalFire
- 200,000 acres were treated and new targeted smoke air pollution monitoring deployed for 233 wildfires
- More state investment is needed for Air Resources Advisors, coordination, tracking, outreach
- Fund new incentive program for "clean air centers"
- More to come: broader package of bills making the rounds
